LINK TO THE RECORDED VERSION OF CLO'S "CHARITABLE RECEIPTING PRACTICES AND LEGAL COMPLIANCE" WEBINAR

CLO is pleased to offer another Valentine's Day treat for community-based literacy agencies. On January 26, 2011, CLO offered a free webinar for its members programs on "**Charitable Receipting Practices and Legal Compliance**"

Charity lawyer Mark Blumberg reviewed the "dos and don'ts" of charitable receipting. Here are just a few of the receipting topics Mark covered:

- When is your charity allowed to issue official donation receipts and for how much?
- What is a gift and how do you determine "fair market value" for gifts-in-kind?
- What are the top receipting mistakes and abuses and how do you avoid them?
- What are the Canada Revenue Agency's top receipting concerns?
- What are the issues, problems, and consequences that can arise from improper receipting?

Mark also discussed the top legal compliance issues registered charities need to understand to protect their charitable status. He then opened up the webinar for a question and answer session. Over 35 literacy practitioners joined us for this lively and informative webinar.

UPDATE ON CLO'S NEW PROJECT: "BEST PRACTICES IN ONLINE LEARNING FOR ADULT LITERACY STUDENTS LEARNING AT THE LOWEST LEVELS OF LITERACY"

AND... YOUR OPPORTUNITY TO GIVE INPUT...

Community Literacy of Ontario has recently received funding from the Ministry of Training, Colleges and Universities for a project called *"Best Practices in Online Learning for Adult Literacy Students Learning at the Lowest Levels of Literacy"*.



Ontario's Literacy and Basics Skills programs are leaders in providing online instruction to adult learners. Due to their very low reading levels, the learner group hardest to serve online is adults with the lowest levels of literacy (levels 1 and 2). However, some Ontario literacy agencies have had success in delivering online instruction to this group of adult learners.

In our project, *"Best Practices in Online Learning for Adult Literacy Students Learning at the Lowest Levels of Literacy"*, Community Literacy of Ontario will research how online learning for adult learners at the lowest literacy levels is being delivered in Ontario's community literacy agencies. We will also assess the benefits, barriers, strategies and best practices.

We then will develop a resource guide that summarizes the research and best practices. In December 2011, this guide will be circulated to community literacy agencies, literacy networks, and MTCU. It will also be available online. CLO will also develop an annotated online listing of helpful online instructional resources as identified by literacy instructors during the research.

CLO staff are contacting diverse community-based agencies and other stakeholders to learn about strategies and best practices for online learning with Level 1 and 2 adult learners.
