THE NEW OSAP: GRANTS FOR ADULT LEARNERS TO ATTEND COLLEGE OR UNIVERSITY

Are your students looking at their postsecondary options? Don't forget to remind them to apply for OSAP! Starting in the 2017-18 school year, OSAP will make the average college and university tuition free for students, including **adult learners**, whose family income is \$50,000 or less per year.

Even if their family earns more, the new OSAP is still there to help with generous grants and loans that will make attending college or university much more affordable.

Adult students, married students, and students with children are eligible for grants for university or college through OSAP.

LBS MEETING WITH DEPUTY MINISTER SHELDON LEVY

Representatives from Community Literacy of Ontario, CESBA, Literacy Link South Central, the Peel-Halton-Dufferin Adult Learning Network and COFA were pleased to attend a meeting on February 23rd with Deputy Minister Sheldon Levy and Assistant Deputy Minister Erin McGinn, on behalf of

our colleagues from many of Ontario's support organizations.

The meeting was very positive and productive. We discussed the benefits of the Literacy and Basic Skills program, the need for enhanced program funding, and the need for increased recognition of LBS within the Ministry of Advanced Education and Skills Development. Our small group will be writing a more in-depth update which we will share at a later date. We all very much appreciated this opportunity to both showcase the importance of LBS programming and to also raise concerns.



THE LBS PROGRAM: A FEW HIGHLIGHTS

Here are a few important statistics about Ontario's Literacy and Basics Skills program from the Ministry of Advanced Education and Skills Development's EOIS-CAMS Data for **2014-2015**. This is provincial data, which is inclusive of all regions and all LBS delivery sectors and streams.

- LEARNER NUMBERS: In 2014-2015, the LBS program served 43,617 adult learners.
- **EDUCATION LEVELS: 44% of** adults in LBS have not attained a high school education. **24%** have a high school education only.
- LBS AND POVERTY: Lack of literacy skills is strongly linked to poverty and over 45% of LBS learners rely upon Ontario Works or the Ontario Disability Support Program for income support.
- LABOUR FORCE ATTACHMENT: LBS learners experience high levels of unemployment, and 57% of learners are unemployed. This contrasts sharply with the standard unemployment rate for Ontarians.
- LBS LEARNERS ARE SURPRISINGLY YOUNG: 45% of learners served by Ontario's LBS agencies were youth under the age of 29.



SUPPORT ORGANIZATION CORNER

Literacy and Basic Skills organizations are supported by a variety of support organizations, including provincial and regional networks located in various communities across the province.

Learning Networks of Ontario

Eastern Ontario Literacy Networks

Ontario's Eastern Literacy Networks have created a professionally produced video called "Occupational Health & Safety: The Literacy Connection". Health and safety and injury prevention are important topics, but literacy students often face barriers to access this training due to their low literacy skills. The video shares how the networks worked together to create a health and safety course designed for clients with literacy challenges, and they also share how this course can enhance safety and employability skills.



Best Practice Interviews with LBS Programs

The Western Region Support Organizations collaborated to interview LBS champions in a series of four interviews, called "Best Practice Interviews with LBS Programs". The interviews cover the following four topics: Completion of Goal Path; Learner Progress; Service Coordination; and Suitability.








ANNOUNCING THE WINNER OF CLO'S MEMBERSHIP DRAW
